Updates from 4-H National Headquarters

<u>Protocol for multi-state and national 4-H events</u>. All multi-state 4-H events need to submit their information to the national database of events. This allows us to have a national repository of multi-state events, published on the web, with contact information for each event.

Any event wishing to use "National 4-H" in their title, must apply for that designation. Those applications are more involved and include the submission of event materials and a logic model. Applications are reviewed by a team of your peers for program quality and accountability processes.

Common Measures Message

Very excited to transition 4-H Common Measures to the Qualtrics platform. All data deposited in the original Common Measures system will be transferred to your new Land Grant University Account within Qualtrics. In addition, you'll find enhanced resources related to analysis and reporting, the ability to customize instruments with the addition of site specific questions and language translation and pre/post resources will be coming soon.

To provide each Land Grant University access to the new and improved Common Measures system we have created an account for each LGU. In the current system your LGU account could have multiple user names and passwords with varying degrees of permissions. Due to our licensing structure, the new system allows for each LGU account to be associated with a single user and we will need your help to identify that person for your LGU. This will still allow Land Grant Universities to maintain control over their data and based on your IRB requirements you can determine the person(s) at your LGU who will have access to the account, but you will operate under a single username and password as opposed to multiple user accounts. You may choose to share access with a small group of users, but there will be one person identified as the Account Manager.

To assist you identifying the correct person, please consider the following:

- The Common Measures Account Manager will provide oversight for the use of 4-H Common Measures instruments at your LGU.
- He/She will work with staff in your state to respond to opportunities for administration of the instruments.
- He/She will be responsible for the development of instruments and will provide access for copies or links for administration of the surveys.
- Your contact could be an Extension or 4-H Evaluator or any 4-H professional who has the capacity to manage the site and coordinate the sharing of resources.
- He/She will not need expertise in survey development or administration and in fact we recommend this responsibility is shared by the users of the instruments.
- He/She will need to participate in a web-based training to introduce them to the resources and familiarity with Qualtrics or other commercial survey systems would be helpful.
