## **Logic Model Update**

Mark reported on the SET Logic Model work that Dr. Cater, Dr. Boleman and Dr. Maxa have been working on. In looking at the National 4-H SET Logic Model, the model is very general. The SET Logic Model recommendation was to be more specific. The Southern Region 4-H SET logic model focused on the following outcomes: Short Term Outcomes - Environmental Issues and Career Opportunities; Medium Term Outcomes - Youth use skills in planning, organizing problem solving, decision making, goal setting and teamwork. Youth will feel empowered to make a difference in the environment; Long Term Outcome - Increased environmental stewardship and advocacy; increased ability to solve environmental issues; and increased capacity to make career choices.

## **Southern Region Strategic Directions Team Account Update**

After discussion, it was determined that the Southern Region Strategic Directions Team Account can remain at LSU AgCenter. The fund has been used to support youth from North Carolina and Florida who serve on the National 4-H Club Congress Planning Team. It was recommended that the LSU AgCenter notify the sponsoring state when youth and volunteers are reimbursed.

# **PLN Meeting Agenda Focus - FCS**

The focus will be collaborating with FCS. In his position, Marshall participated in the Southern Region FCS Program Leaders meeting in Washington. During the PLN meeting, it was suggested that we highlight outstanding collaborative programming efforts between 4-H and PLN. He talked about potential common themes: K-12 education; Healthy Living and Entrepreneurship. We need to have about 1 hour to 1 hour and half discussion on integrated programming. Marshall volunteered to work with the FCS/4-H Collaborative Issue on the agenda. Do we want to focus on the methods to collaborate or actual issues? It was recommended to set up a process to tackle an identified issue and take the group through the discussion. Health and nutrition would be an easy starting point. Mark, Marilyn, Kellye and Dorothy volunteered to serve on the group that helps with this.

# **National 4-H State Leader Webinar Report**

National 4-H Headquarters presented a New State 4-H Program Leaders Meeting webinar. Mark reported that the webinar continues to talk about the tax exemption, and the structure of National 4-H Headquarters. The webinar is very positive. The information will be posted on the National 4-H Headquarters website. Marilyn was also on the conference and recommended that Mark send out the link when it gets posted.

## **Southern Region 4-H Volunteer Forum**

Mike Klumpp of Arkansas is providing leadership for exhibits. A discussion

was held on travel budget and how they might impact participation in the Southern Region 4-H Volunteer Forum. While budgets will have some impact, the group felt that volunteers and staff who wanted to participate will find a way to attend the Forum.

## **National 4-H Shooting Sports**

Susan Holder and Tom Koonce from Michigan are providing leadership to the National 4-H Shooting Sports Steering Committee which is group who is providing leadership for the Shooting Sports program. During the meetings, there was discussion about reviving the Teen Ambassador Program through which funds have been generated. The funds have transitioned to and are now managed through National 4-H Council. There will be a Level Two Instructor Training in West Virginia in May. The Shooting Sports Invitational will be held in Grand Island, Nebraska.
