- <u>Strategic Communication White Paper:</u> The paper is being finalized by Frankie, Bob and Ruth. Frankie will distribute it to the committee by Monday, Dec. 3, for review. Feedback from members is due to Frankie by Dec. 17. Deadline for completion of the project is Feb. 20, 2013.
- <u>Social Media Best Practices Initiative:</u> Frankie will contact the appropriate members of the IT and PSD committees to see what initiatives they are currently working on regarding social media to ensure we aren't duplicating efforts. Policies, procedures and best practices from various institutions have been compiled and are under review.
- <u>Research for white paper on strategic communications role of extension administrators:</u> Discussion of the research structure took place, as well as the appropriate scope of the paper (targeting educators, administrators, both?) Ruth will meet with Maria and Suzanne to plan the next step in researching the white paper. Suggestion is to spend the fall semester researching the situation, forming hypotheses and research methodology and share the research structure with the committee; actual conducting of research would be done in the spring. The goal is to have the project outlined, a formal statement of the hypothesis and a definitive recommendation for how to proceed ready by February. The team will have something for the committee to review a week prior to the February meeting.

New Business:

• Frankie and Ayanna will attend the PLC meeting in Atlanta Dec 5-6 to begin planning the 2013 PLN conference in Nashville. Suggested topics include: revisiting social media and how what we've learned since the 2012 meeting has been implemented; celebration planning for the centennial anniversary of the Smith-Lever Act in 2014 (a survey will be coming from ECOP soon); better contact management initiatives; the new/next wave of leadership in the Extension system and the challenges that brings; the continued relevance of the current leadership structure in the changing system; a panel discussion about the future of Extension with panelists from eXtension, ECOP, and someone from outside the higher education arena.
