Update re: SRDC Director Status - Interviews complete; selection process moving forward

NIFA Update - Brent Elrod

- FY14 budget and 2014 Farm Bill implementation are underway.
- A number of RFAs are open, see http://nifa.usda.gov/fo/funding.cfm for the up to date listing. If you are not responding but are interested in reviewing, contact the National Program Leader responsible for the particular announcement to share your interest. See https://prs.nifa.usda.gov/preLogin.do;jsessionid=FE59EFE77BBFA5623417B182FAB98E 25?page=welcome to create a peer review account.
- Mandated programs in the Farm Bill include the Beginning Farmers and Ranchers program and for the first time we'll include a 5% set aside for veterans. The goal is to have most competitive RFAs out by June.
- Highlights of the NIFA budget include:
 - An increase of \$9 million above 2014 for a total of \$325 million for the Agriculture and Food Research Initiative;
 - o Continued support for capacity funding, minority-serving, and other programs;
 - A new investment creating public-private partnership of Innovation Institutes focused on emerging challenges to agriculture;
 - o A new program to engage Veterans in the agricultural sector; and
 - A new program to support training and outreach activities in food safety to assist small producers, processors, and vendors.
- The agency is preparing FY16 budget requests.
- Brent encouraged program leaders to visit him when in DC and share what is going on in their states and to provide input to programming
