2. Advisors Report-Shirley Hastings (TN) and Gina Eubanks (LA)

Roll Call

- Dr. Gina Eubanks Military 4H Program On Dec. 19, 2012 the ECOP Chair shared that the Army is taking more control over the 4-H Programs; therefore, it appears that NIFA does not have as much control over this process.
- SNAP ED The Legislative budget has been reduced by 28% for this year only. The HRA deals with the Tax to avoid the Fiscal Cliff. It was reported that due to the reduction in the budget, the University of Wisconsin may have to cut employees because their budget is allocated for salaries.
- SNAP –ED is set for an increase each year and scheduled to for the budget will increase during the 2014-2015 and a larger amount of funds will be available. In 2016 the budget will return to original increases.

- Corner Stone indicated that a 1 Year Farm Bill extension. SNAP-ED has 150 million allocated for Extension which is the largest part of the SNAP-ED budget.
- "Bo" J. Beaulieu, Southern Rural Development will be leaving Mississippi State March 30, 2013 Bo Beaulieu will be going to Perdue University as the Director of the Center for Regional Development. The Farm Bill that was not mandated is not in the extended part of the Farm Bill. It was suggested that the Southern Program Leaders Network do something to thank Bo Beaulieu for all of the work and support he has provided in promotion of programs for the Southern Region.

Krystal Smith and Jorge Atiles will write a letter and Brian volunteered to help.

- 3. PLC Report 1862-Anne Sortor (AR) (PLN)Refer to Kris Grimes notes
- 4. PLC Report 1890-Kris Grimes (KY)
  - a. The tentative theme this year is "Connecting with Communities: Preparing for the next 100 years". This is an effort to celebrate the Smith Lever Act in addition to recognizing our need to reach new audiences with the same message in new packaging.
  - b. There will be a call for proposals for workshops rather than the PLC generically coming up with topics. These workshops need to address the theme in a specified way. Some of the topics might be (but are not limited to) Social Media, Urban Programming, Funding Opportunities, Multi-State Collaborations, Marketing, etc. There will be two sessions for this most likely with some of the workshops repeated if necessary.
  - c. Cross-Committees "may" be replaced by the additional workshop above.
  - d. There is a recommendation that committees have action/information items drafted prior to the meeting so that more of the committee meetings can specifically work on how to accomplish each item. With this in mind, we may want to send out an email in advance of the January meeting in order to generate ideas. While this may make our preparation a bit more intense prior to the meeting, I believe that this is a great suggestion.
  - e. The PLC felt that we should go with an outsider for the Keynote in order to address the theme. I think that this is a positive move. They are currently looking at Devin Fidler, a futurist, who many have heard and felt that it would be a good move. With that said, they are seeking other ideas for a back-up. Suggestions are strongly welcomed.
  - f. They are looking to have a lunch speaker on the first day to speak about Smith Lever Act
  - g. We are raising the registration fee from \$325 to \$350 in order to help pay for the speakers and incidentals.
  - h. I recommend that we, FCS, bring in a Military Families person and a grant funding person to specifically speak to our needs during our committee meeting. (Speaker Extension Generally (outsider to speak that are not normally invited.)

- i. I also recommend that several from FCS propose compelling workshop ideas to be considered during the specified time. This will give FCS more of a voice among the groups. (Have someone from the university develop a really compelling workshop, innovative, action related workshops....participants can see a project moving.)
- j. Kris is on the committee that is developing a call for proposals. (Action oriented concept is being pushed).
- Approval of Minutes-Krystal Smith (WV) and Paula Threadgill (MS) No changes to the minutes – Krystal will send the minutes to the Southern Region.
