**Approval of Minutes:** The minutes from the previous meeting were accepted.

# Advisor's Report: Gina Eubanks reported:

- She has been selected as the 1890 representative to the Board on Agriculture Assembly.
- A joint meeting was held during the ECOP meeting with Dr. Roger Beachy from NIFA. Research will be driving the agenda and the lay public needs to understand how research will benefit them.
- Dr. Beachy discussed the four institutes: Food Production and Sustainability; Bioenergy, Climate, and the Environment; Food Safety and Nutrition; and Youth and Community Development.
- The 1890 Association of Extension Administrators will partner with EDEN and conduct trainings. The winter meeting will be held in Savannah, Ga.
- Capacity building grants are great opportunities for 1890 and 1862 schools to collaborate.

## **ECOP Meeting:** Jorge Atiles reported:

- The Board on Human Sciences will seek clarification about including family in the name of the fourth institute.
- Dr. Beachy will be meeting with BoHS members at the APLU conference. He will also be asking for recommendations for a director of the fourth institute. Mary McPhail Gray is a good candidate for that position.
- The BoHS will elect the new liaison from the Southern Region.

#### **SNAP-Ed Asessment**

- The directors voted down the assessment, they want to grow state resources.
- Linda Kay Benning is conducting a system-wide survey to identify what directors can
  do to grow SNAP-Ed. Shirley Hastings is the representative from the Southern
  Region.

- A spring meeting is possible during the Priester National Extension Health Conference.

#### **Cross Committee Issues**

- Healthcare Extension Initiative
- CoP for Community Health
- Electronic Medical Records with an Education Component
- Mississippi and Alabama are taking the lead on CoP for Community Health.

Ellen Murphy suggested that we use high-tech methods for communication such as webinars and Wiki. The IT committee could partner with FCS for this component.

# NIFA Update: Caroline Crocoll reported:

- There has been lots of conversation since the 2008 Farm Bill about transferring to NIFA
- There will be major policy decisions involving science.
- There will be more resources for NIFA. The status of NIH will be elevated while growing REE functions.
- A Center for Human Sciences is being proposed.

#### Q. Will there be a change in the national program leadership?

**A.** There is a national program leader for Child and Adolescent Development. They are interviewing for a 4-H and Youth Development Director and are close to hiring someone for CYFAR. There will be a growth in military positions.

### **Q.** Is extension experience requested?

**A.** Yes, Human Resources assesses the applications and then they are forwarded to the next level. Sometimes, applicants with extension experience do not make it to the next level.

**Q.** How likely is it that someone from FCS will be selected as the director of the Youth and Community Development Institute since family is not included the title?

**A.** There are still some senior executive deputy directors that need to be placed. We need to be purposeful with the planning and recommendations for that position.

## Southern Obesity Summit: Carolyn Nobles reported:

- The Southern Obesity Conference addressed current issues in obesity and strategic planning and education with communities.
- Public health officials look to a medical model but personnel is needed on the ground to implement these intervention strategies.
- The next conference will be held in Atlanta, Ga.

**FCS Administrator's Meeting, NEAFCS:** The Extension Dietetic Internship proposal was presented at the NEAFCS and received great support.
