- 2. Guest Speaker Dr. Craig Wood. Associate Director, eXtension Initiative IT Update.
 - New version of 'Ask An Expert 2.0' went live December 2012. Since the release eXtension reports an increase in the questions asked via AAE. Learn recorded session https://learn.extension.org/events/818
 - eXtension is now using Basecamp to manage projects. This web applet
 has assisted in the managing of eXtension projects, communications, and
 documenting conversations around each project. https://basecamp.com
 - Content Management Added reporting module into the Drupal platform, so community of practices can generate annual reports. eXtension media module is also being refined for entering metadata at the same time you upload the image. This will assist communities of practice as they search for images related to content questions.
 - Looking at mobile applications, and how eXtension can efficiently develop applications for communities of practice. eXtension is working through questions of what platforms and standards to develop applications for. Currently they are enhancing current content so its mobile friendly.
 - Total redesign of extension.org, should go live in the near future. Outside design firm was contracted for this project.

Rhonda Conlon asked about public questions within AAE centered on the duration of the questions and how long an agent must monitor these questions? Dr. Wood said they haven't come up with a set time period but eXtension is looking into this. Right now no notifications are sent out to agents if a comment is left within AAE to questions they've answered.

eXtension evaluation is underway, the actual report will be completed within six to eight months.
