III. ASRED & AEA Updates

- a. Ron Brown (ASRED)
 - i. CSREES has officially become NIFA as of October 1st. Roger Beachy is the Director
 - ii. Formula funds: Southern Region Directors have drafted a proposal calling for a balanced portfolio between competitive and formula funds. This dual funding strategy is being vetted nationally.
 - iii. Health Care Legislation: Dr. Brown has written a white paper proposing that language be added to the Health Care Bill to fund Health Care Extension. He is also working with a national group appointed by ECOP. Senator Harkin (Iowa), former chair of the Senate Ag Committee, and who is familiar with the LGU system, is now chair of the Senate Health Committee.

 - i. Comments were, in general, very positive.
 - ii. The presentation by Drs. Brown and Lyons was extremely well received. We may want to consider including this session every year.
 - iii. There were a few quirks with the hotel initially, but those seemed to be worked out quickly.

b. Rotation of future conferences: In order to keep costs low, the SRDC is proposing a rotation schedule among 3-4 hub city hotels within the Southern region. By committing to a rotation, hotels are more willing to give price breaks to help keep costs low. Proposed rotation cities are: Memphis, Dallas-Fort Worth, and Orlando. Charlotte was initially considered, but removed from the list because of high Internet charges that would significantly raise the registration costs. PLC members approved the proposed rotation of the three cities.
