- 2. Update from AEA Gina Eubanks: AEA will have its summer meeting next week in St. Louis.
- 3. Update from ASRED Ron Brown, Tony Windham:
  - a. The budget is a serious concern for the Land-grant system. The directors have been working with Cornerstone on the issue. The House voted on the budget last night or today. Emphasis will switch to the Senate.
  - b. The Southern Extension and Research Directors are working jointly to draft a white paper on the criticality of Formula Funds. The paper will be sent to the other three regions for buy-in.
  - c. In order to develop multi-state/multi-discipline teams, ASRED will be working in the region to identify top 2-3 priorities for the region around which these regional teams can be developed.
