Documenting Impacts and Telling our Story:

- NIFA's interest in measures of Rural Vitality Crystal
 - Alison Davis shared there was a conversation regarding this at NEAFCS. Nothing else to report at this time.
- State Level Indicators Collection Alison
 - The subcommittee has met and is updating/editing the indicators based on feedback from the August meeting. There was some discussion about capturing work done with non-profits, including enhancing organizational capacity through enhance by-laws, board governance, 501c3 status obtained, etc. It was agreed that the subcommittee members would give more thought to this organizational development work.

- Further development of regional CD indicators Susan Jakes
 - The committee is still working on these.
- Southern CD agent training (Institute for Sustainable Development) Alison Davis
 - FCS program leaders from Tennessee and Georgia expressed interest in the CED101 training. The Institute for Sustainable Development is a big undertaking and is done jointly with other states. It may be held on the eastern seaboard or further south. Alison asked about other states interested in the training. For CD101, a state by state model might work – or a joint training with a neighboring state.
- Recruit 1890 Institutional Partners to Attend a Ready Community Training for Agents and EM Partners
 - 4 sites have been selected and the anticipated training date is January 2015 at Prairie View A&M University
- Determine next steps for we can continue to engage county commissioners Not on call
- Utilize to landgrantimpacts.org to distribute impacts Not on call
- Hold a Southern Region meeting to assess gaps and key opportunities (incl. urban & local foods focus) for CRD programming to build capacity across the Southern Region Alison
 - This was an action item from PLN. It was shared that Southern Risk Management Education Center did a meeting on local foods and want to keep going. There was some discussion that local foods is the way to keep CED alive. SRDC is working on a regional effort to assess what the needs are in the field? The focus will be to bring together agents, specialists, and middle managers to discuss needs. Alison will email dates to ask for interested names to hold a conference call. It was also noted that names were collected at PLN and are listed on the Plan of Work for those who were present and expressed interest.
