### **Old Business**

Update on Health Extension Specialists pre-conference to NHOC-

Lisa Washburn reported on preliminary plans. The overarching challenge the committee seeks to address is providing support from a state perspective level, while developing programs for local level, collecting data that supports the scholarly work specialists need to advance.

The following sessions were discussed:

- Program planning with publishing in mind from the beginning, but still useful on a local level. Nancy Franz was invited but is not available. Joseph Donaldson from UT was suggested as he has worked on county and state levels, on JOE board; He uses the Reaim framework that aligns with public health. Ahlisha Shipley wants to be involved and may know of other across country who might meet this need.
- Grant writing from state level but appropriate for counties
- Policy Systems and Environment Looking for someone to address PSE's and how to apply in Extension work. The KY Coordinating Center for Nutrition Education and TN center for PSE might add to the discussion. Using CDC on the agenda as well as the southern region's centers so both CDC and Extension understand how each are positioned to address health PSE's. And how does this position us for interstate grant projects. Leslie sent a document she just located about PSE's.

Registration details: will be set up as a southern region event. Others can join if they like, but will be marketed to southern region.

Networking and Discussion: Time will be set aside to foster collaboration, share interest areas, etc. The plan is to send registrants and potential registrants information prior to the conference so they can be prepared at the session to discuss potential collaborative projects. .

Timing: Discussion regarding 9 a.m. to 5 p.m. versus beginning with a luncheon, and whether folks are able to travel in the morning or whether forced to come in the previous evening. The committee will investigate flight schedules into Roanoke.

Program leaders need to be thinking about supporting a health specialist to attend this preconference.
