## NIFA Update:

Leslie introduced Beverly Samuel, Southern Region Liaison from USDA – NIFA, who discussed the NIFA Calls to Conversation. There is an upcoming Call to Conversation being held June 14-15 in St. Louis to gather information and stakeholder input on the EFNEP program. She mentioned that two calls have been held over the past year: one on "Engagement and Success of Land-Grant Universities and Colleges – Respecting Sovereignty, Serving the People and the Land," and one on Tactical Sciences. NIFA is putting together a team to address threats to the food system. In August, the University of Georgia, Fort Valley State University, and NIFA will undertake a Call to Conversation regarding Positive Youth Development (PYD). Budget: Dr. Ramaswamy is happy that the proposed budget from the White House only cut NIFA funding by 5%. They are still waiting on the outcome from Congress. NIFA has approval to fund 18 new positions. FCS is in the next round for position requests.

Grants: RFA announcements operating on the premise that they'll get the same amount of funding in FY18 as in FY17. FY17 funds have to be awarded by Sept. 30. We all need to take advantage of grant funding.
