## Welcome and Introductions-Jacquelyn White, PLN/FCS Chair

Updates

- 1890 Administrative Update Dr. Rosalind Dale
  - 1. System-wide AEA conference in Orlando, Florida next year.
  - 2. 1890s many of the program leaders that support 1890s do not plan to move when NIFA relocates. This may impact historical knowledge and working relationships.
  - 3. In regards to mental health, Dr. Carolyn Williams has sent out a memo to all 1890 administrators to poll who has staff doing mental health work.
- 1862 Administrative Update Dr. Rich Bonanno
  - 1. Very small percentage of people moving to Kansas City due to USDA/NIFA relocation. Looking for staff now to fill upper level positions. Many positions vacant.
  - 2. Be patient about funds, may not come as quickly due to transition.

Updates from NIFA Representative Beverly Samuels

- Compared to other NIFA program areas, the FCS Division has two vacancies currently. However, this is not reflective of those who may not be moving to Kansas City for the relocation of NIFA which should be final by September 30, 2019.
- Apprised the group on NIFA's talking points on top issues.
- Grant funding may be available for industrial hemp programming.
- There are three revised/new knowledge areas in FCS
  - 1. KA 804. Human and Environmental Issues Concerning Apparel and Textiles.
  - 2. KA 807. Disaster Preparedness, Mitigation Response, and Recovery.
  - 3. KA 808. Human Issues in Residential and Commercial Structures.
- New grant initiatives:
  - 1. Food and Agriculture Defense Initiative
  - 2. AgVets
  - 3. Farm and Ranch Stress Assistance Network

Dr. White led a group discussion in reference to reviewing the 2019 Plan of Work/Annual Accomplishments and updating the 2020 Plan of Work/Annual Accomplishments.

Michael Gutter presented on Partnerships with Health Sciences Campuses-Mapping to Systematize

- SERA-47 Project Strengthening the Southern Region Extension and System to Support Local & Regional Food s Needs and Priorities
  - 1. The annual meeting in Savannah, GA will be one full day on December 12, 2019, after the Community Food Systems Conference.
- NC1196 USDA Research project focuses on Food Systems, Health, and Wellbeing: Understanding Complex Relationships and Dynamics of Change.
  - 1. The annual meeting will be in October or November 2019 in Texas.

Dr. Sarah Baughman gave an informative presentation about the Military Families Learning Network.

- The network promotes readiness and quality of life of Service members and their families.
- The mission is to connect military family service providers to timely and cogent research, the Cooperative Extension Service and to each other.
- The network sponsors podcasts that focus on real life topics affecting military families.
