Mary Poling shared Zoom growth and utilization for the past three years documenting its adoption rate and significant impact on program delivery and cost savings for Arkansas' Extension programs. • Amy Cole, Director of Digital Media Program Director for the University of Arkansas System Division of Agriculture Cooperative Extension Service, is serving on the Horizon.x expert panel representing web based technologies and social media. • University of Kentucky.
