- Report from PLC Representatives Carolyn Williams (1890), Martha Ray Sartor (1862) PLC Representative serve a three year term and help plan conferences (this includes participating in conference calls and face to face meetings).

 - 2. 2015 meeting will be in Orlando, 2016 probably in Nashville
 - 3. Make sure new officer names and Administration leader are submitted to Rachel Wilburn
- Report from our Administrative Advisors Celvia Stovall (1890), Joe Zublena, NC State (1862)
 - 1. Celvia Currently serving on ECOP. Many CES are focusing on health and nutrition and probable wave of the future. In 2017 even more focus on this. Taskforce is being formed to help with this issue. Probably no new federal budget until 2015.
 - 2. New funding in farm bill to educate farmers about the details of the farm bill. FSA will be sending funds to state. Required 20% match.
 - 3. ECOP voted to remain in Extension Marketing initiative for one more year.
 - eXtension Taskforce Discussion on how to market eXtension and if states are still committed to supporting it. Proposed increase in eXtension budget from 1.3M- 2.6M? dollars. Different **levels** of support for eXtension are available.

 - 6. Technology public has new technology on the "front end" of innovations. Younger employees are more in tuned to new technology.
 - 7. Dr. Ramiswami is requesting more useable success stories, but still room for improvements in success stories. Wants one per month for every state.

- There are currently 19 1890 universities. Most recent Farm Bill designated Central State University in Ohio as the 19th 1890 land grant university. However, there are no funds.
- 9. New funding sources were discussed.
- 10. July 2015 will be the 125 anniversary of 1890 institutions.
- Joe Z Extension is continuing to focus on support for formula funding in Washington.
 Some Southern states feel that the federal report is additional report. Still working on that.

Review 2013-2014 Plan of Work-Update Status of Current Items - Comp<u>l</u>eted Be sure to share MM newsletters to state directors.

Discussion on Local Food Systems – brief discussion of the topic Darrell asked about a few weeks ago.

Tennessee – Ben West - highest growth in the number of farmer's markets. Topic cuts across all program areas, but have had limited success.

Georgia - Sheldon Hammond – discussed food deserts in urban communities. Mobile fresh food delivery truck to help train people on how to prepare fresh foods. This was received positive reviews locally and nationally. Attract small local farmers to communities. Continue to provide food safety training. Work with larger farmers to donate lower grade produce to food banks. Trying to manage the overwhelming requests getting to interact on the topic. Commissioner of Agriculture is focusing on communication breaking down between growers and users. Need to speak language consumers can understand.

Mississippi – Alcorn State – focus on community gardens, farm to school programs, vegetable processing facility. In regard to funding – approaching legislators asking for dollars for issues not agents or location.

NC – Sheri Schwab – Dedicated point person and there is a district "local foods" coordinator in each district and county (unusually FCS or/and ANR/Hort). Also working on the concepts of Food Hubs, Web portals, CSA's. Started a taskforce(Fall) to determine what Extension's role in this whole issue. Creating 5 local food modernization agents and three food safety agents Localfood.ces.ncsu.edu

Food safety – "Safe Plates" practice based and experiential training

Texas – Community Gardens, programming between program areas, contact with Walmart to grow strawberries, reestablishing relationships with researchers on Asian Melons and other types of melons,

LSU – Bobby Fletcher – hired Animal Specialist working with LA Dept. of Ag, GAP contact person hired, cross programming opportunities, Comparison on poultry litter and chemical ag products on effects on soil fertility, sponsored **Food Systems Forum?** to identify best practices, partnerships to help leverage additional resources, Food incubator at LSU to help process local grown / prepared foods. Sponsored a Farm to Table Conference. Urban Extension website created. Farmers markets have shown increased interest. SNAP funds used to hire agent in Shreveport, LA. Strong alliance with Shreveport Parks and Recreation and Extension /4-H programs.

- **Oklahoma** Farm to School Program in conjunction with Dept. of Agriculture. Working with American Indian tribes for farmers market vouchers. Community Gardens are also important
- **Kentucky** Community School Gardens for FFA/4-H, Hiring Bi-lingual employees to work with migrant workers, Food Hubs, multi-program area efforts to address food issues
- Virginia Mini Gardens, Community Gardens, Youth Ag Days,
- NCAT Lonette. Working mostly with horticulture issues, eg. high tunnels
- **Arkansas** Arkansas Coalition for Obesity Reduction. Focus on increased physical activity and improved nutrition. Interest in basic food information. Experiment station field days beef and horticulture.
