- 1. Welcome Rhonda Conlon, PLC Chair
  - December meeting minutes were approved with minor corrections.
- 2. Update from AEA Carolyn Williams
  - AEA had a very good winter meeting, January 26-29. Almost all national program leaders were in attendance. Dr. Ramaswamy provided an update on Extension at the national level, shared other changes in their offices in DC, and discussed funding opportunities and encouraged attendees to apply. Related to funding, there will be an increase to cover the addition of Central State University as the 19th 1890s LGU.
  - The meeting also focused on the 125 Anniversary. One activity all 1890 universities will participate in on "1890 Day" is a Wellness Walk on 4/23/15. The \$18.90 fee to participate will support scholarships. The website is up at http://1890universities.org/.
  - Administrators will be participating in the CARET meeting in March (http://www.omnihotels.com/hotels/washington-dc-shoreham/meetings/aplu-2015caret-ahs-meeting). That meeting will also highlight the 125 Anniversary.
- 3. Update from ASRED Ron Brown, Paul Brown, Ed Jones
  - The President's budget for NIFA seeks a large increase in AFRI, moving the total to \$450 million. There is also a move to make \$20 million of capacity funds available on a competitive basis, which our system will oppose. The President's budget seeks no increase in Smith-Lever or Hatch funds, but does seek increases for 1890 and 1994 institutions.
  - ASRED will meet jointly with SAAESD April 6-9 in Roanoke, VA. We are expecting an interesting and informative meeting.



- The National Impacts Database (NIDB) has been developed and a roll out is expected March 2. Communications units should expect information that can be used in publicizing and encouraging use of the database. Being able to communicate impacts of our programs is increasing in importance.
- Dr. Laura Johnson is the new Associate Dean and Director of Extension at the University of Georgia.
- Ed Jones and Woody Hughes, Jr. represent the southern region on the national 4-H Leadership group; a report from this group is expected soon.

    - How to proceed / facilitate. Acknowledged that we need strong plan with strong facilitators. ChaNae B. and Dawn Mellion-Patin volunteered to help Rhonda figure out a plan to propose to committee by April meeting.
    - Rhonda will also ask Rachel to help us figure this out.

**ANR – Dawn Mellion-Patin** Well attended committee meeting on 2/13/15. Joint meeting with North Central region in June where they will be meeting with USDA representatives and in regional meetings.

**MM – Carolyn Williams** Committee met 2/12/15, with several members unable to attend. They discussed the National Impact Database launch. Dr. Ramaswamy conveyed the importance of Research/Extension integrated programming impacts. They discussed the upcoming MM Conference. Registration is complete and shows good attendance. They also discussed the National Urban Conference. Directors and Administrators are being actively encouraged to attend. The monthly newsletters continue. The last one covered difference onboarding strategies and the next will cover creative ways to use support staff to support agent activities.

Carolyn also mentioned the inclusion of a 125 Anniversary recognition at the PLN meeting. That is slated to be a part of one of the lunches.
