## 2020 Joint AEA-ARD Winter Business Meeting

In January 2020, members of the Association of Research Directors (ARD), the Association of Extension Administrators (AEA), and the Council of 1890 Deans of Agriculture held their third annual joint business meeting at the Westin Georgetown Hotel in Washington, D.C. Again, this gathering of 1890 administrators was very engaging and productive and, by design, engaged in critical discussions about pressing issues confronting the 1890 universities. The meeting focused specifically on the 1890s centers of excellence, the 1890 scholarship program, FY 2020/2021 appropriations and advocacy, the NIFA reimagining process, entrepreneurship, successful collaborations between research and Extension, and communications and marketing. These sessions were very impactful, both content-rich and allowed sufficient time for discussion of other concerns crucial not only to the 1890s but to the land grant system.

# **NIFA Reimagining Input**

Dr. J. Scott Angle, NIFA Director, posed four questions for the land grant community to respond to relative to improving the efficiency and effectiveness of NIFA. In addition to email inquiries to the 1890 community, Albert Essel (AEA Executive Administrator) and Alton Thompson (ARD Executive Director) convened a session of 1890 administrators at the recent 2020 AEA-ARD Joint Business Meeting to augment written responses to these questions and to inquire about any other concerns and/or pertinent issues. The major concern of the 1890 administrators was the extent to which NIFA can be responsive, effective and efficient given the significant loss of key personnel because of the relocation to Kansas City. A related concern is the one or two persons remaining who are articulate and knowledgeable of 1890 programs.

## Extension Committee on Organization and Policy (ECOP) Spring Meeting

Dr. Mark Latimore, Jr., Extension Administrator, Fort Valley State University, will host members of ECOP at the 2020 ECOP Spring Meeting in Atlanta, Georgia on March 17-19, 2020. Dr. Latimore is the ECOP Chair for 2020. The Extension Committee on Organization and Policy (ECOP) is the representative leadership body for the Cooperative Extension System, a Board of Directors representing all 1862 and 1890 Extension Directors and Administrators in the nation.

#### 2020 AEA System Wide Conference

Plans continue for AEA to host a System-Wide 1890 Extension Conference in June 2020. The conference will be held at the Renaissance Orlando at SeaWorld in Orlando, Florida on June 21-25, 2020. The goal is to provide a forum for Extension educators, specialists, administrators, research professionals, public and private partners to learn, share innovative ideas, best practices and explore collaboration opportunities for advancing impact-driven extension programs in the 1890 Extension System. Professional development workshops, exhibits and presentations on innovations and best practices will dominate the 3-day conference. Last held in 2012, the conference is expected to draw wide range participation from 1890 Land-Grant institutions, 1862 Land-Grant partners, USDA agencies, other public and private sector partners. ## **President's FY2021 Executive Budget Proposal**

With last month's release of the President's Executive Budget for FY 2021, there is a lot of review and strategy planning taking place among the 1890s. Simply stated, all of the gains in capacity funding



achieved by the 1890s noted in FY2020 were eliminated in the FY 2021 President's Budget. Specifically, the Evans- Allen Program (research and education) was cut by 19.4% (-\$13 million) and 1890 Extension was cut by 14% (-\$8 million). These proposed budget cuts are clearly draconian. In addition, the Capacity Building Program was also reduced by 19% (-\$3.7million) and the 1890 Facilities Program was reduced by 4% (-\$770,000). The President also proposed to eliminate the 1890 Centers of Excellence; however, the President proposed to increase the 1890 Scholarship Program from \$5 million to \$10 million.

### 3. Update from ASRED:

Dr. Ron Brown reported for ASRED.

- The President's budget recommends reductions in all capacity lines, moving all Extension and Research capacity lines to what they were prior to last year's increases. Those units who received larger percent increases last year are recommended for larger decrease percentages this year. The Budget and Advocacy Committee (BAC) is recommending 8% increases for all capacity lines and for AFRI. The 1994 recommendation is larger since their budgets are smaller.
- Directors are responding to a survey to determine ECOP Strategic Initiatives for the next 3-5 years.
- NIFA has a Reporting Work Group for Extension with the goal of simplifying and streamlining the reporting system. Dr. Robert Burns represents ASRED.
- Directors have responded to four questions issued by NIFA that will help in a NIFA Re-Imagining
  effort. Feedback from Dr. Angle indicates that good, usable information has been received and will be
  used in improving NIFA services.
- ECOP is discussion ways that Programmatic Leadership can be improved. In the past, NIFA provided program leadership via National Program Leaders, but has discontinued this function. National leadership for Extension is now a concern. ECOP will discuss three models: Regional leadership, Initiative Leadership (Health), and 4-H ECOP Leadership Committee.
- The search for a National Extension Executive Director to replace Dr. Rick Klemme is nearing the end.
- The deadline for Excellence in Extension and National Diversity Award nominations/applications is May 1. Our regions (1862 and 1890) have been well represented in the past and should be again this year.
- Dr. Tom Dobbins, Clemson University, is ASRED's Chair for 2020. Dr. Nick Place, Florida, was elected to join Drs. Ed Jones and Gary Jackson on ECOP for 2020.

## 4. 2020 PLN Conference – Opportunities in Transition: Driving Change:

- Review of draft conference agenda
  - o The conference logo was discussed, and the group was pleased with the design. A special thanks to Michelle, and her colleague Brittany Hughes for this work.
  - Robert Burns approached Gordon Gee about speaking at PLN, but Dr. Gee declined citing pressing responsibilities. Mitzi will reach out to Marshall Stewart of University of Missouri.



The "TED Talk" type presentations and format were discussed. Due to possible copyright infringement, we cannot use the same terminology, and therefore several ideas for branding were presented: EXT Talks, Extension Talks, EXT Change Talks, and EXChange Talks. Russ will send out a Doodle poll to canvas the group.

- Michelle gave a brief overview of the potential Fun Run on Wednesday, August 26, providing two routes that can be followed. There will be waivers provided, and a facilitator will be coordinating the run. It will be scheduled to be completed by the time breakfast is served (7am).
- The subject of tours was discussed, and it was decided to let the program areas communicate tour information among their own networks. It was emphasized to let Samantha know as soon as possible the details of the tours, as far as when, how many, ect. in order to plan accordingly for mealtimes.
