- 1. June 18th minutes and today's agenda were approved as presented.
- 2. Update from AEA Vonda Richardson
 - A session on Coming Together for Racial Understanding (CTRU) will be part of the AEA/ASRED joint session in August
 - Joint COPS meet next week virtually, including the ECOP meeting
 - Carolyn Williams participated on the National Agricultural Research, Extension, Education and Economics (NAREEE) Board panel discussing the future of Extension
 - eXtension is facilitating a discussion on Extension infrastructure needs around virtual training and educational programs. This will include a discussion on broadband infrastructure. Rachel added that some resources on broadband and digital literacy are also on the National Extension Education Team site: <u>http://srdc.msstate.edu/ecommerce/</u>
 - Three 1890 Centers of Excellence have been funded that include research and academic integrated efforts. All 19 institutions participate in all three. Topics and host institutions are:
 - International engagement University of Maryland Eastern Shore
 - Small farms Tuskegee University
 - Student success North Carolina A&T University
- 3. Update from ASRED Ron Brown, Gina Eubanks, and Randy Taylor
 - The South is the only region where all states have CTRU teams. AEA/ASRED is eager to build on that strength.
 - ASRED. along with the other four regions, is working on a new initiative to build capacity funds (Smith-Lever and Hatch). Both 1890 and 1994 funding showed good increases in the proposed House budget.
 - Chris Watkins is the incoming chair of ECOP. A strategic directions document is being built to guide the upcoming 3 years.
 - Dr. Bob Scott is the new CES director at University of Arkansas.



- Dr. Rick Cartwright, recently retired CES Director for Univ. of Arkansas, was honored for his work in supporting 4-H throughout his career by the contribution of over \$40,000 in scholarship funding for the 4-H Foundation.
