The state reports are not required this year. As a committee do we want to have state reports for our use? If yes, what questions do we want to answer? (target audience is us)

Discussion:

- Verbal discussion of what is happening in states or written reports? If verbal discussions are conducted we must be conscientious of our overall limited meeting time as a PSD group. Verbal discussion was noted as having value for the entire group.
- An idea for facilitating the state update discussion is to have a topic or theme. For example, budget challenges and the role PSD can play while the organization restructures or downsizes or otherwise respond to budget situations. Challenges that we share need to be very specific. Statements such as "downsizing" do not provide the needed insight for possible solutions others may use. A more thorough response beyond "downsizing" might be an explanation that the state is moving from a county based delivery system to a regional system, followed by the personnel redistribution challenges.

Summary:

After discussion, the decision was made to not require or ask for formal written state reports. Further discussion generated the idea of establishing a topic or theme for verbal state updates.

- ➤ Karen will work with Virginia to establish a topic or theme for the state update conversations.
- State reps should be prepared to share challenges during the August meeting. Karen and Virginia will provide further details on how this conversation will be facilitated.
