POW Updates: Committee Reports

1. Social Media Strategies & Best Practices presented by Della Baker

Niki, Debra, Gloria Long, and Della met in January 2012 after that month's conference call meeting to decide on a strategy. They discussed our interest regarding the PSD plan of work topic and on how to proceed; They developed a document that included questions that we thought could go to the states in a web based format in order to gather as much information as possible. The findings could be shared with all states.

Della contacted members of the Communications and IT Committees that were assigned to work on this topic and asked what they had done or what they plan to do. The IT Committee was planning to meet on Feb 9th (Terrence Wolfork). The Communications Committee was planning to meet on February 15 (Robin Adams and Frankie Gould). Della contacted Nikki and Debra to share information that she had compiled for Clemson on Using Social Media Wisely.

Della shared these questions and a possible format for the survey with the total group electronically. She contacted everyone again on February 16 about setting up a phone conference call. Two persons responded, so they did not have the call. About Mid-March, Frankie Gould from LSU sent an e-mail to everyone asking about a good time to meet. Debra suggested that the meeting be held after the federal report due date. That is the last correspondence that she has received.

Following Della's report, the Committee conversation focused on who to send the surveys to and what information we really want to collect and the 3 questions her committee proposed:

- 1) What types of social media guidelines or policies are being used by states (relative to sharing information with clientele?
 - Will be sent to PSD staff to be key contact to follow up at local institution

These 2 questions will go through the chairs of the various S-PLN committees to distribute and ask for response from committee members.

- 2) How is social media being used for training in various states?
- 3) What training resources or products are being used by states to train faculty/staff?
 - Be sure to include an option for responding by state/institution.

2011 conference generated some excess funds that can be applied to 2012 conference. Association theme for year is "Using Technology."

Call for proposals will be released in the next 4 weeks.

3. Report from Advisors Karen Ramage (1862) & Vernon Jones (1890)

ASRED met last week (So Region Ext Dir)

- a. Southern Directors have decided to support another grantsmanship workshop, date to be determined; start looking for loosely formed groups around particular issues or topics that could be selected to write grants for NIFA funds; more information will be coming forward
- b. ASRED discussed how to bring 4-H ACCESS report into REEPort was a discussion. Someone will be examining how to make it easier to share data across reports.
- c. eXtension—continue to encourage each institution to develop implementation teams and encourage greater use among Extension professionals.
- d. Batelle Study on Perception of Extension; NC Region has done a similar study; anticipates this study will be up and running in late summer; hopes to get more information on what learned and how NC Region used data
- e. Directors are supportive of NAEPSDP

Dr. V. Jones did not attend this call.

Information and Action Items

Changes in PLN Leadership – Scott received notice that the current chair of PLC needs to step down; Scott is chair-elect and will be having to step into chairing the 2012 meeting (he will continue with the Chair role in 2013).
